It is with great pride and much pleasure that the **WEST ISLIP BICENTENNIAL COMMITTEE** invites you to participate in our 35th Annual Country Fair- a very special event in our community!

PLEASE READ THE FOLLOWING VERY CAREFULLY!

Acceptance in our Country Fair is based upon the nature of the craft and the date we receive the required form. **FIRST TIME APPLICANTS MUST SUBMIT A CURRENT PHOTOGRAPH OF THEIR CRAFT AND DISPLAY!** Failure to provide a photo with your application will automatically eliminate the applicant. Previous participants are encouraged to update their file with current photographs.

Due to the large number of participants in our Fair, only **ONE vehicle and ONE parking permit** will be given for each paid vendor space. NO extra parking permits will be given to anyone. Adherence to using only assigned spaces will be strictly enforced!

Two applications are enclosed. **Keep one for your information** and return the other with the **non-refundable** fee of \$75.00 **before** the deadline date of **April 30, 2010**.

AGREEMENT

I, the undersigned Country Fair applicant, understand that it is **my responsibility** to provide all materials, tables, chairs and equipment necessary for my participation in the West Islip Country Fair. I am also responsible for the clean up of my booth area at the end of the day. This includes removing all emptied cartons and containers. **Nothing can be left on the fairgrounds!!!**

The West Islip Bicentennial Committee (WIBC), the West Islip Public School District and the Public Library shall not be held liable for any damage, theft, or injury, which might occur during the hours of the Fair. I, as participant, am solely responsible for my property and person at all times. Entry in the Fair constitutes an agreement that I and/or my co-workers will take no legal action against the WIBC, the WI School District or the WI Library.

The non-refundable \$75.00 fee, which accompanies this agreement, entitles the participant to **one space** (10' by 10') and **one parking permit** for one space. Multiple spaces may be requested.

I, the undersigned, agree to and accept all the regulations set forth by the WIBC. In the event that I am unable to take part in the Fair, I will notify the committee in writing.
